Community Prosecutor report – Assistant City Attorney Chris Dixon	<p>Chris Dixon introduced himself as the new 5<sup>th</sup> Precinct community prosecutor. Dixon has 15 years of experience as a prosecutor, including nine years with the City Attorney’s office and six years with a district attorney’s office in Georgia working on felony cases, including a number involving narcotics trafficking. Dixon stated that he is happy to be here and excited to meet and work with community members.</p> <p>Dixon distributed copies of the 5<sup>th</sup> Precinct CLEAN sheet, which is at <a href="http://www.ci.minneapolis.mn.us/police/about/docs/Pct5CLEAN.pdf">http://www.ci.minneapolis.mn.us/police/about/docs/Pct5CLEAN.pdf</a>, and provided updates on some Stevens Square offenders:</p> <ul style="list-style-type: none"> <li>▪ Pamela Beaulieu is in the workhouse for a prostitution conviction until 8/12, at which time she is due to appear in court on a 5/22 charge of possession of liquor in a park.</li> <li>▪ Darryl Brooks fled from an officer after committing crimes at 1801 LaSalle Ave on 6/24 and will be charged by complaint.</li> <li>▪ Pamela Cobenais is restricted from the area from LaSalle Ave/Blaisdell Ave to 4<sup>th</sup> Ave, I-94 to 24<sup>th</sup> St.</li> <li>▪ Osbin Davis was released from jail on 6/18 and was due in court today on an open bottle charge.</li> <li>▪ Tammie Houle appeared in Mental Health Court on 6/13. 	<p>There was a discussion about how to stop other offenders, those who are not on the CLEAN sheet, from committing crimes here. Citizens are encouraged to call 911 to report criminal activity; the police want this information. The City Attorney's office handles between 30,000 and 60,000 cases a year, and therefore, due to this huge caseload, needs to concentrate on prosecuting the worst offenders. The membership of the CLEAN sheet is updated quarterly to include the offenders causing the most problems in the precinct. It appears that the City Attorney's office will lose a number of prosecutors through upcoming budget cuts.</p> <p>The 5<sup>th</sup> Precinct's pilot project to increase domestic assault convictions has been very successful and is being expanded citywide.</p> <p>Day beat officer Deb Hubert will be out on medical leave during July.</p>

<p>Ward 6 report – City Council Member Robert Lilligren</p>	<p>Robert Lilligren congratulated the committee and the police for the significant drop in crime this year.</p> <p>Lilligren reported on the city's budget situation. The city is facing cuts in local government aid from the state of \$8.5 million in 2009 and an additional \$21.3 million in 2010 as a result of the governor's plan to unallot funds in order to balance the state budget. The city now receives 43% less annually in local government aid than it did six years ago. Anticipating severe cuts from the state, the city eliminated \$17 million from its 2009 budget in January, so no more reductions need to made this year. Federal funds will also offset some of the lost revenue. Citizens are encouraged to closely watch the city's 2010 budget process as priorities are being set. Block Patrol report	<p>Arlene Storandt reported that, from 5/29 to 6/24, 6 Block Patrol volunteers participated in 9 regular shifts, contributing a total of 20 hours. One shift was cancelled. Safety coordinator report	The coordinator reported on a proposal from some Board members to eliminate committee “co-chairs” and instead have the committees each elect a chair and vice chair, similar to the arrangement used by the Board. This may involve designating an appointed seat on the Board for each committee, which would be filled by the chair or vice chair depending on whom is available to attend the meetings. The details would need to be worked out by the Executive committee, the current committee co-chairs, and the Board. Two committee members expressed the opinion that the current co-chairs arrangement, which has been in place for many years, works well and asked why SSCO would want to change a process which is not broken. Using 311 to solve problems in the neighborhood – 311 Director Don Stickney	Don Stickney said that he enjoys attending neighborhood meetings and educating community members about ways to use 311 to alleviate problems. 311 is the number to call for information or services provided by the city. Stickney said that SSCO’s executive director had contacted him last fall with questions about what issues had generated 311 complaints in the neighborhood and whether those complaints could be tabulated. As an example, Stickney provided data regarding the top five service requestes from Stevens Square-Loring Heights for April and May, along with the service goals and percentage of responses meeting those goals. Here are the totals for the issues which generated more than five complaints:	Call 311 for Minneapolis information and services.

April 2009

17 parking violations – 58% of the responses met the 5-day service goal.

6 graffiti reports – 100% of the responses met the 20-day service goal.

May 2009

19 graffiti reports – 100% of the responses met the 20-day service goal.

11 parking violations – 82% of the responses met the 5-day service goal.

City staff constantly looks for ways to improve service response as the number of reports and complaints to 311 continues to grow and citizens become accustomed to using the system, which began in January, 2006. 311 operates Monday through Friday (except on holidays) from 7 a.m. to 11 p.m. Further information is available at <http://www.ci.minneapolis.mn.us/311/>. The number of online service requests has risen to almost 10,000 per year. 311 is working to expand service by incorporating information and referrals from more departments. 311 tracks response times against service goals, and looks at whether the goals are reasonable and if/where there are problems in the system which need to be addressed.

Council Member Lilligren said that the data gathered by 311 is valuable in showing how the city is performing and is included in Results Minneapolis, the new web site which provides performance information on the city's key issues: <http://www.ci.minneapolis.mn.us/results/>

Stickney said that 311 plays a key role in the city's emergency preparedness system, too, such as during the 35W bridge collapse and the GOP convention. He asked community members to contact him directly – [Don.Stickney@ci.minneapolis.mn.us](mailto:Don.Stickney@ci.minneapolis.mn.us) – if if they are dissatisfied with 311's service and invited the committee to visit the 311 facility at the 3<sup>rd</sup> Precinct for a tour. In response to questions, Stickney acknowledged that there are still problems with the system which need to be resolved – such as occasionally slow computer response times due to heavy traffic on the servers, and how online reports about parking violations are dispatched to Traffic Control. Some users recommended calling 311, rather than reporting online, to get a faster response.
