

SSCO Community Safety information sheet, March 24, 2016

Part 1 crimes reported in Stevens Square-Loring Heights, February 26 to March 24 (source: Crime Prevention Specialist Chelsea Adams)

- 1 apartment burglary: 3/11 at 1901 Lyndale Ave, unlocked apartment, suspect is a family member.
- 1 motor vehicle theft: 3/20 at 124 Groveland Ave, parked in the driveway.
- 3 thefts from motor vehicles: 3/17 at 229 Ridgewood Ave; 3/20 at 124 Groveland Ave; 3/20 at 18th & Clinton.

- **Patrick Addy** is in jail on \$3,000 bail with 12 cases (five gross misdemeanor trespassing, one gross misdemeanor obstructing, six misdemeanors) set for Mental Health court on 5/3; supervised by P.O. Morgan Miller.
- **Dahir Yussuf Aden** is in custody in Ramsey County until 5/12 and has an active arrest and detention warrant in Hennepin County; supervised by P.O. Roxane Watson.
- **Sharee Barrett** has been conditionally released to treatment pending a court appearance on 4/19 for 11 cases (two felony 3rd degree burglary, nine misdemeanors).
- **Darryl Brooks** has active warrants for 3 cases (gross misdemeanor trespassing, two misdemeanors).
- **Reginald Charging Thunder** is in the workhouse until 5/29 for gross misdemeanor trespassing; supervised by P.O. Morgan Miller.
- **Jules Chomilo** is in prison until 10/31 for 5th degree felony possession of drugs.

Update on 8/4/15 incident:

Mohamed (or Mohammed) Ali Elmi (1/1/90) is charged with kidnapping, three counts of 1st degree criminal sexual conduct, and two counts of 1st degree aggravated robbery for an incident on the 1800 block of 2nd Ave on 8/4/15. Elmi is in custody on \$1,000,000 bail plus a Department of Corrections hold without bail – he was on supervised release from prison at the time of this incident. Elmi has been in custody since 8/5/15; a pretrial hearing is set for 4/8 and a jury trial is scheduled for 5/31.

Alcohol-related offenses include consuming alcohol in public, open bottle, and possession of liquor in a park.

Narcotics-related offenses include narcotics violation, loitering with intent to buy or sell narcotics, and possession of drug paraphernalia.

Prostitution-related offenses include prostitution, loitering with intent to commit prostitution.

SSCO submitted a community impact statement to the court for the following cases:

Rahsaan Wells (3/19/76, 9 prior convictions in Minnesota) – 5/11/15 to 5/13/15 burglary of business and criminal damage to property at 214 East 19th St. SSCO asked the court to sentence Wells to the maximum amount of time in custody or to restrict him from the Stevens Square – Loring Heights and Whittier neighborhoods if he is conditionally released.

Mohamed Ahmed Farah (1/1/84, five arrests in the area during 2015, 21 prior convictions in Minnesota) – 12/11/15 disorderly conduct at Loring Nicollet Alternative School, 1925 Nicollet Ave. SSCO asked the court to sentence Farah to the maximum amount of time in custody or to restrict him from the area if he is conditionally released.

SSCO's monthly chronic offender update included cases involving:



Eugene Watkins (8/31/96)

Case 5/6/15, 1st degree murder with intent while committing a felony at 2101 3rd Ave. (15-162706)

Outcome On 1/5/16, pled guilty to 2nd degree murder with intent, not premeditated. On 3/7/16, the 1st degree murder charge was dismissed. Sentence for 2nd degree murder: 360 months, with credit for 307 days served. Anticipated release date from prison: 5/7/2035

Trevone Seantez Little (2/4/94)

Case 5/6/15, aiding an offender – accomplice after the fact, at 2101 3rd Ave. (15-162706)

Outcome On 1/20/16, pled guilty. Sentenced on 3/8/16: 86 months, stayed for three years, serve 365 days as work release, with credit for 9 days served. Conditions of release: supervised probation; follow all state and federal criminal laws; obtain and maintain employment; remain law abiding; no use of alcohol or controlled substances; psychological and psychiatric evaluation / treatment / counseling; cognitive skill training.

Rahsaan Migel Wells (3/19/76) 9 prior convictions in Minnesota since 1996 for domestic assault (3), 5th degree assault, possession of burglary or theft tools (2), theft, criminal damage to property, and 3rd degree burglary.

Case 5/11/15 to 5/13/15, 2nd degree burglary and criminal damage to property at 214 East 19th St. (15-173298)

Outcome On 10/21/15, pled guilty to 2nd degree burglary at an address on the 2200 block of Colfax Ave South on 5/6/15. Sentenced on 3/8/16: 39 months, with credit for 30 days served, to be served concurrently with a 30-month sentence for 3rd degree burglary which occurred on 3/21/14 and resulted on 7/17/14 in a dispositional departure from the state sentencing guidelines by Judge John McShane in which the defendant was ordered to serve 90 days (with option for work release) and then placed on supervised probation. The case from 214 East 19th St was dismissed. Pay restitution before fines, fees, and surcharges. \$75 court fees waived. Pay \$50 fine and additional \$78 court fees. Anticipated release date from prison: 4/9/18.

Harry Paul Leftbear (11/25/60) 21 arrests in the area in the past six years. 47 prior convictions in Minnesota for larceny from building, 3rd degree burglary, theft (5), 5th degree assault (2), 2nd degree burglary, escape from custody, disorderly conduct (4), consuming alcohol in public (6), trespassing (11), open bottle (9), interfering with traffic, public urination (3), giving police a false name, and felony 4th degree assault of a police officer.

Case 1/21/16, interfering with traffic at 1933 Lyndale Ave, cited by day beat officers. (16-022436)

Outcome On 2/11/16, this case was dismissed. Pled guilty to gross misdemeanor trespassing from 1/18/16; misdemeanor disorderly conduct and gross misdemeanor 5th degree assault charges were dismissed. Sentence: 365 days, 300 days stayed for two years, serve 65 days, with credit for 8 days served. Report to the workhouse on 3/3/16 or serve the entire 365 days. Conditions of release: supervised probation; remain law abiding; no use of alcohol and controlled substances; no contact with victim(s); chemical dependency evaluation / treatment. \$75 court fees waived. Pay an additional \$78 court fees. Failed to report to the workhouse; warrant issued. Arrested for the warrant on 3/17/16. Anticipated release date from the workhouse: 11/5/16.
