Alcohol-related offenses include consuming alcohol in public, open bottle, and possession of liquor in a park.

Narcotics-related offenses include narcotics violation, loitering with intent to buy or sell narcotics, and possession of drug paraphernalia.

Prostitution-related offenses include prostitution, loitering with intent to commit prostitution.

SSCO's monthly chronic offender update included cases involving:



Terry Lee Rean (2/24/70) 3 arrests in the area in the past eight months. 28 prior convictions in Minnesota since 1998 for domestic assault (4), disorderly conduct (4), consuming alcohol in public (4), open bottle (2), theft, receiving stolen property, driving while intoxicated, 5th degree assault (4), trespassing (3), littering (2), violating a no contact order, and interfering with traffic.

Case 6/7/16, trespassing at MN Adult & Teen Challenge, 1717 2nd Ave, cited by squad 510. (16-204920)

Outcome On 7/26/16, this case was dismissed. Pled guilty to a disorderly conduct case also from 6/7/16. Sentence: 90 days, with credit for 22 days served. Serve one day of Sentence to Service in lieu of \$50 fine and \$78 court fees. An additional \$75 court fee was waived. Workhouse release date: 9/1/16.

Marshaund O'Neal (3/11/65) 32 prior convictions in Minnesota since 1995 for violating city weapons ordinances, consuming alcohol in public (9), 5th degree felony possession of a controlled substance, driving while intoxicated, 3rd degree burglary, disorderly conduct (3), issuing worthless checks, receiving stolen property, criminal damage to property, open bottle (5), public urination (2), aggressive panhandling, trespassing (3), criminal contempt of court, and 3rd degree felony sale of drugs.

Case 6/7/16, trespassing at MN Adult & Teen Challenge, 1717 2nd Ave. (16-204920) squad 510

Outcome On 8/2/16, pled guilty. Sentence: 16 days, with credit for 16 days served. Serve 1 day Sentence to Service in lieu of \$50 fine and \$78 court fees. Additional \$75 court fees waived.

Robert John Yellow Wolf (10/29/68) 37 arrests in the area since 2004. 49 prior convictions in Hennepin County for 2nd degree assault with a dangerous weapon (3), aiding/abetting 3rd degree burglary, aiding/abetting 3rd degree assault causing substantial bodily harm, possession of drug paraphernalia, obstructing the legal process, trespassing (9), disorderly conduct (6), criminal damage to property (2), interfering with traffic (2), open bottle (10), consuming alcohol in public (3), fleeing police on foot (2), domestic assault, giving police a false name, unlawfully obtaining transit services, riding public transit without paying the fare, falsely reporting a crime, theft, 5th degree assault, and 3rd degree assault causing substantial bodily harm.

Case 2/16/16, open bottle and interfering with traffic at Groveland & LaSalle, arrested by day beat officers. (16-053267)

Outcome On 7/20/16, pled guilty to open bottle; the interfering with traffic charge was dismissed along with two trespassing cases from 7/17/16. Sentence: 90 days, stayed for one year. Conditions of release: supervised probation; comply with HOMES Court. \$153 court fees waived.
